## Vehicle Theft Suspect Arrested After Short Pursuit

Pacifica, CA—On June 4, 2024, at approximately 1:58 A.M., Pacifica Police Officers were notified by dispatch that a stolen Toyota Prius was last seen leaving Montara, traveling north on State Route-1 (SR-1) towards Pacifica. Officers located the stolen vehicle and attempted to conduct a traffic enforcement stop on SR-1, but the driver failed to yield. A short pursuit was initiated. With the assistance of officers from the San Bruno Police Department, the stolen vehicle's front tires were deflated using tire deflation devices, also commonly known as spike strips. The vehicle pursuit ended on SR-1 near the SR-35 interchange.

The driver and sole occupant was taken into custody without further incident. The subject was identified as 39-year-old Susannah Kathleen Beman, a resident of San Francisco.

Following this investigation, Beman was placed under arrest for the following violations:

- 496D(A) PC- Possession of a stolen vehicle- Felony
- 2800.1(A) CVC- Evading peace officer- Misdemeanor
- 11377(A) H&S- Possession of a controlled substance-Misdemeanor
- 11364(A) H&S- Possession of drug paraphernalia- Misdemeanor
- 485 PC- Appropriate lost property- Misdemeanor
